Privacy Policy

This Privacy Policy ("Policy") applies to www.cagelessbird.com, and Cageless Bird, LLC ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include www.cagelessbird.com. The Company's website is a Home Interiors Service site. By using the Company website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- -First and last name
- -Mailing address
- -Email address

If you purchase the Company's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Sharing Information with Third Parties

The Company does not sell, rent, or lease its customer lists to third parties.

Tracking User Behavior

Automatically Collected Information

The Company may automatically collect information about your computer hardware and software. Use of Cookies
